The rates listed above apply at all Corporate and participating licensee locations in the 48 contiguous states, Puerto Rico, Hawaii, and the District of Columbia. Unless otherwise provided, these rates do not include taxes, LDW, PAI, refueling service fees, or any other extra service fees not specifically included in the rates. No discount shall apply to such charges. Please keep in mind that **all** renters must meet standard Avis age and credit requirements. The daily rates listed above will include unlimited free mileage as long as the vehicle is rented from a participating location and is returned to the same renting city. Renter may take advantage of either corporate or "over the counter" rates at the time of booking or rental. Car classes B through E not returned at the same renting city will retain the daily Corporate rate, but will also be assessed a mileage fee of .35 cents for each mile driven during the rental. Other car classes not returned to the renting city will be charged at an "over the counter" rate and may be subject to a one-way service fee. All rentals on other classes will receive a 5% discount off the "over the counter" rate at those participating locations in the contiguous 48 states, and the District of Columbia and Canada. Cars rented in the state of Florida may be returned to any Avis location in the state of Florida and will not incur any one-way fee. Car classes "G" and "W" are not available at New York Airports, Manhattan, NY Tri-State Area, Philadelphia, Florida and Canada.

#### International

Discounts are applicable where permitted by law to international Time and Kilometer rates. By using the Avis AWD number, Avis offers the following discounts: Western Europe 20%, Africa/Middle East 10%, Asia and Pacific 15%, and Latin America 10% Excluding Puerto Rico.

### **Worldwide**

Corporate rates, discounts, optional LDW limitations and insurance may be modified at any time without written notification. Commercial rates may not be available during peak demand periods. Individual renters must meet Avis age and Credit Requirements.

#### Corporate Awards

Avis also offers the company the money saving opportunity to earn Free Rental Days when renting from participating locations. Each time the company accumulates 15 paid rental days under the corporate AWD number, Avis will send the company a certificate for one Free Rental Day up to a Group G Premium size car. Terms for redemption of the Free Days can be found on the certificates.

### Loss Damage Waiver

For business rentals from Avis corporate and participating licensee locations, the rate will include a maximum responsibility of \$3,000 for damage to the Avis vehicle in the event of a collision or loss. This additional coverage is available only when on a Business rental and the renter complies with all provisions of the rental agreement. Non-business rentals will have the option to purchase LDW where available. This provision is applicable in the 48 contiguous states and District of Columbia.

#### Liability Insurance

The Corporate Rates of this agreement include the liability insurance limits of the state on the rental agreement at the time of rental. Additional liability insurance may be purchased at the renter's option where available.
